- A late payment fee of R200 per child is levied upon all payments made after the 7<sup>th</sup> of the month
- Included in the fees are: Tuition, LTSM (PACES), treats, annual prize giving, school photos, holiday care (excluding June/July and December/ January holidays). This does **not** include After Care.
- Fees are subject to an annual increase from 1 May.
- School fees are payable in advance on the day of commencement of school at QCS and over a twelve month period.
- Payment with respect to Learner Teaching Support Material (PACES), is regarded as a “Usage Fee” and remain property of the school.
- All extras, eg. school uniform, repeat PACES are added to the account and must be settled by the end of the month, together with the school fees to qualify for early payment discount.

- **One month notice is required in writing upon termination of a learner's attendance at QCS. As fees are calculated over 12 months, November and December not a notice month, notice must be received by the 1st October.**
- For end of year termination, notice to remove a learner from QCS need to reach the office none later than 30 September of that year to qualify as "one term's notice".
- Should school fees not be paid by the 10<sup>th</sup> of the month, the learner will be suspended from school untill the necessary payments are made. If the payment is not made by the end of that month, the learner will be removed off the student roll and the account closed and handed over to a debt collector agency. The parent/guardian responsible for the account, will be jointly and separately liable for penalties, legal costs, recovery commission and interest which may arise from the breach of this agreement.
