- 2.5. One month notice is required in writing upon termination of a learner's attendance at QCS. As fees are calculated over 12 months, notice given in November must include December.
- 2.6. Payment is to be made into the following bank account:

2.7.2. Payments must be made via EFT or paid directly into the school account. No cash or cheques.

4. DEFAULT

- 4.1. Applicants acknowledge that monthly school fees must be paid and reflect in the school's bank account by the 7th of the month.
- 4.2. The Applicants acknowledge and agree that, notwithstanding any remedies that may be available to QCS in terms of this agreement and in law, should the invoiced amount not be paid:
- 4.2.1. by the 8th of the month will be handed over to the credit bureau for administration, the learner will be automatically suspended from school until the payment is made in full, and the arrears are brought up to date. All costs incurred are for the account of the parent.
- 4.2.2. if fees are not paid up to date by the last day of the month, the learner will automatically be taken off the student roll, a transfer card and report issued, and the credit bureau(TPN and Trans Union) will commence with formal debt collection and possible blacklisting. All penalties due are for the account of the parent.
